#### 2007 LEGISLATIVE PRIORITIES

Prince Jonah Kūhiō Kalaniana'ole started the Hawaiian Civic Club movement in 1918, and today our Association is a national organization with more than 50 clubs and 2,800 members. We are the oldest grass roots Hawaiian organization in Hawai'i and we work to support a number of initiatives that benefit the native Hawaiian community.

Every year delegates from each club convene to consider and debate a wide-range of issues facing the Hawaiian community. The outcome of the debates sets the legislative priorities for the following year.

Here are our priorities for the 2007 Session of the Hawai'i State Legislature:

### 1. OHA Salary Commission

Requires the salary commission for members of the OHA Board of Trustees to meet every year to recommend salary compensation.

STATUS: To be introduced in OHA Legislative Package

#### 2. Re-affirmation of Native Hawaiians as indigenous

Recognizes that descendants of races living in Hawaiian Islands prior to western contact are the aboriginal, maoli peoples of Hawai'i.

STATUS: Bill is being drafted; introducer identified

#### 3. Education & Act 133 (2004)

Urges Board of Education, Department of Education and Universities to adopt directives of the act relating to Hawaiian language.

STATUS: Bills need to be drafted; introducer needed

#### 4. Health Screenings

Requires medical insurers to cover prostate and colorectal cancer screenings.

STATUS: Bill is being drafted; introducer needed

## 5. State Funding for 'Iolani Palace

- Appropriation in Governor's budget for palace climate control system
- Application for a Grant in Aid

STATUS: Testimony support needed

### 6. Ocean, Coast and Land Management

Creates a permanent 'Aha Moku to ensure Native Hawaiian practices and knowledge are considered in decision making related to ocean resource management.

STATUS: Bill being drafted by OHA; introducer needed

#### Other initiatives being worked:

#### -Culture

**Urging** the Governor of the State of Hawaii to Proclaim 2008 the Year of the Great Waiomina Centennial Celebration. Intent is to honor the Hawaiian paniolo and support the Paniolo Preservation Society that was established in 1999 in planning a hear-long celebration to honor the ranching industry and the Hawaiian paniolo

**Urging** the AHCC to Develop a Program for Teaching Hawaiian Culture, Language and to Understand Hawaiian Attitudes and Needs. **Urging** the Governor and the Hawaii State Legislature to Appoint Representatives from the Association of Hawaiian Civic Clubs to Serve on the Hawaii 2050 Sustainability Task Force and to Each Island's Working Group. Intent is to assure perspectives of the Hawaiian community are considered

**Urging** Legislation to Require the State of Hawaii to Require the Hawaii Superferry to Conduct an Environmental Impact Statement on all Islands

Urging Kanaka Maoli and the General Public in Hawaii to Support the Ku'e Memorial Wall Project

**Urging** the AHCC and the State of Hawaii to Affirm and Support the Sacred, Cultural and Historic Significance of 'Iolani Palace and the Palace Grounds
